I also am aware that termination of this agreement will not release me from the obligation of paying all past due monies concerning the instrument, past fees, or any other outstanding payments owed to Wakefield Music, LLC.
2. _____ Damage and Repairs – I, the purchaser, am aware of the instrument I have chosen to purchase and the condition thereof. I am aware that the instrument is being sold "AS IS" with no further obligation from Wakefield Music, LLC unless I have chosen to purchase an additional warranty package.
3. _____ Loss or Total Damage – I, the purchaser, understand that I am fully responsible and still under contract for the instrument and will continue making payments until all remaining balance is paid in full.

1. This warranty is a limited liability coverage.
2. Loss or Excessive Damage is NOT covered under this warranty.
3. Warranty is limited to NORMAL wear and tear due to proper and average playing. Any damage that is beyond NORMAL wear and tear is NOT covered. The case and cover within the case is not covered by the warranty.
4. This warranty covers
 - A. 1 (one) set of student grade strings, as needed, every 6 (six) months, including labor.
 - B. 1 (one) pin replacement, as needed, up to every 12 (twelve) months, including labor.
 - C. 1 (one) nut replacement, as needed, up to every 12 (twelve) months.
 - D. 1 (one) saddle replacement, as needed, up to every 1 (one) year.
5. Warranty parts and labor MUST be provided by Wakefield Music, LLC.
6. There is NO reimbursement plan for outside labor or parts.
7. This warranty contract may be terminated at any time, but may not be added or re-added after 10 days of original contract signing.
