Violin/Viola/Cello/Bass lessons are \$100 per month for weekly 30 minute lessons, \$60 per month for a 2 lesson option, \$80 for a 3 lesson option, \$165 per month for weekly 60 minute lessons; monthly options are not interchangeable and will not be prorated. All monthly tuition includes the monthly master class. There are no refunds for no-show lessons. If the teacher has to cancel, you will be notified and a credit will be applied to the account. Monthly fee does not include instrument rentals.

Sarah offers a 10% off total tuition if you enroll 2 or more children in her strings program.

___ I understand that I must provide a 3 ring binder, page protectors, note paper, and a writing utensil for this class. The teacher will be adding specialty pieces, practice logs, homework, and Master Class Lessons to this binder. This will also be a primary point of contact for important upcoming dates, as well as general information between Sarah and Guardian.

___ I understand that to get the most out of the lessons, the student needs to stay on task and keep the conversation on topic, as we are VERY restricted on a time schedule.

___ I understand that if the Student is unable to take adequate notes during class, or understand the homework; An adult is encouraged to attend the class with the student to do so.

___ I understand that Private Lessons are paid in advance for the month.

___ I understand that I am responsible to provide 2 weeks notice if I choose to withdraw, and if I fail to do so, I am responsible for those 2 weeks tuition.

___ I understand that if I miss more than 3 private lessons without notice, I may be dropped from the class and put at the end of the waiting list for private lessons and must re-enroll (including the enrollment fee). I understand that I am still financially responsible for any missed lessons without adequate notice.

___ I understand that class will start promptly at the scheduled time, if the student is more than 10 minutes late for their scheduled private class, that the remainder of the class will be cancelled. Make up classes may be available for an additional fee.

___ I understand that when the student arrives, they need to unpack and knock on the door when it is time for their lesson.
